

ANNEX NO. 1:

BEHAVIORAL GUIDELINES FOR THE ROZÁLKA PEZINOK HEALTH RESORT PREMISES

The Rozálka Pezinok Health Area (hereinafter referred to as "the area") is a publicly accessible space, with the exception of clearly marked zones designated by signs, where entry is permitted only to horse owners, staff, or authorized personnel. The purpose of the area is to provide the public with opportunities for active recreation, access to equestrian sports, and interaction with animals in a safe and regulated environment.

Given the specific nature of the area, the presence of animals, and the necessity to uphold safety standards, all visitors are required to adhere to the following rules of conduct:

1. GENERAL RULES OF MOVEMENT AND CONDUCT

- Movement within the area is permitted only on designated concrete walkways and in publicly accessible spaces.
- Entry into stables, horse paddocks, and other marked zones is strictly prohibited.
- The use of bicycles, scooters, rollerblades, and similar vehicles is forbidden outside designated areas.
- Ball games and other recreational activities are allowed only in designated areas, such as the children's meadow near the accommodation section.
- Loud behavior, shouting, and any activities that may startle the horses or disrupt the functioning of the area are prohibited.
- Feeding horses in the paddocks is strictly forbidden due to potential health risks.
- Visitors are required to maintain cleanliness—waste must be disposed of only in designated containers.
- Please respect all informational signs and follow the instructions of the area's staff.
- Visitors must behave considerately towards other people, riders, and animals, and must not obstruct the movement of horses.

2. RESPONSIBILITY FOR CHILDREN

- The safety and behavior of children are the sole responsibility of their legal guardian or another accompanying adult.
- The Rozáľkovo children's playground is intended exclusively for children, who must be under constant supervision by an adult to prevent possible injuries or accidents.
- Entry to the Rozáľkovo children's playground is allowed only under the conditions set by the operator and in accordance with the current price list. The admission fee may vary for selected groups based on granted exceptions. The operator also reserves the right to modify entry conditions and admission fees in connection with children's events or other special activities.
- Only hotel guests are exempt from paying the admission fee; no other exceptions are granted.

3. RESPONSIBILITY FOR ANIMALS

- Entry with a dog is permitted only if the dog is on a leash.
- The dog owner is fully responsible for the animal's behavior, hygiene, and safety throughout the entire visit.
- Animals must not pose a threat to other visitors, children, horses, competitors, or staff.
- Animals must remain under control at all times and are not allowed in areas where they could endanger the safety or comfort of others.

4. RESPONSIBILITY FOR SAFETY AND CONDUCT WITHIN THE AREA

The Rozálka Pezinok Health Area makes every effort to ensure the safety and comfort of visitors. Nevertheless:

- Every visitor moves around and uses the facilities at their own risk.
- Adult visitors and activity participants are responsible for their own behavior, compliance with the rules, and the safe use of equipment and premises.
- The operator is not liable for injuries, accidents, or damages resulting from rule violations, personal negligence, or inappropriate behavior.

5. VIOLATION OF RULES AND CONSEQUENCES

In the event of a violation of any of the above rules, the operator reserves the right to:

- Immediately expel the visitor from the area without entitlement to compensation,
- Demand full compensation for any damages caused.
