ANNEX NO. 2: OPERATING RULES – BASIC RESPONSIBILITIES OF RIDERS WHEN RIDING IN THE HALL AND ARENA OF THE ROZÁLKA HEALTH AREA

ARTICLE 1 – GENERAL RULES FOR THE MOVEMENT OF RIDERS AND HORSES

- 1.1. Riders moving at the same gait (pace) are required to pass each other on the lefthand side.
- 1.2. The faster gait (so-called faster pace) always has the right of way when riding along the outer wall of the arena/hall.
- 1.3. Every rider must ride considerately towards other participants.
- 1.4. The trainer/instructor (according to the official list of authorized persons) or the horse owner is responsible for the rider and horse.

ARTICLE 2 – SAFETY MEASURES

- 2.1. All riders under 18 years of age are required to wear a protective riding helmet during every ride. No exceptions will be accepted.
- 2.2. Persons over 18 years old use a helmet at their own risk; however, its use is strongly recommended.
- 2.3. The use of mobile phones during riding for making calls, watching videos, or listening to music is prohibited.
- 2.4. Wearing only one earphone during riding is allowed, and solely for training purposes in accordance with equestrian sport rules.

ANNEX NO. 2: OPERATING RULES – BASIC RESPONSIBILITIES OF RIDERS WHEN RIDING IN THE HALL AND ARENA OF THE ROZÁLKA HEALTH AREA

ČLÁNOK 3 – LONŽOVANIE A ÚDRŽBA KONÍ

- 3.1. Lunging horses is prohibited in the large hall, the main arena, and the training area.
- 3.2. After leaving the arena or hall, the rider is required to:
 - clean the horse's hooves,
 - immediately remove the horse's manure from the riding surface (arena) after leaving the arena.
 - 3.3. Tying horses in the stable aisles is prohibited.
 - 3.4. The grooming and washing box may be used for saddling. Grooming the horse is permitted only in the horse's own stall and in the grooming box.

ARTICLE 4 – MAINTENANCE OF RIDING SURFACES

4.1. Daily maintenance of surfaces is carried out as follows:

LocationSchedule (2× daily)

Large hall / Main arena

6:00 - 7:30, 12:30 - 13:00

Arc hall / Training area

7:30 - 8:00, 13:00 - 13:30

The operator reserves the right to perform continuous maintenance of the arenas during the summer months, including watering outside the times specified in the table, to ensure optimal conditions for the riding surface.

- 4.2. During maintenance, the riding areas are inaccessible the movement of horses in the arena is prohibited.
- 4.3. The operator reserves the right to modify the maintenance schedule and access to the halls and arena in the event of events, planned repairs, or unforeseen circumstances.
